Due Dates and Late Fees

Contracts postmarked after the due date will be assessed a late fee of \$25.00. There will be no exceptions to the late fee if you are a returning or past contracting skater. Skaters who are contracting for the first time will have the late fee waived.

Adding/Changing/Canceling Sessions

Sessions can be added to a contract without incurring the late fee. Sessions changed or cancelled after the due date will be assessed a \$15.00 per session cancelled or changed. Injury credit will be given to those skaters who miss more than one week of skating and can show proof with a doctor's note.

Switching Sessions

Skaters may switch contracted sessions only on the same day. For example: a skater is unable to skate their 7:45-8:45am time, and would like to skate 10:00-11:00am on the same day, they may do so. The sessions may not carry over to another day.

***One exception will be among families with multiple skaters. Skaters in the same family may switch sessions amongst themselves, between any days, without penalty.
