### **Due Dates and Late Fees**

Contracts postmarked after the due date will be assessed a late fee of \$25.00. There will be no exceptions to the late fee if you are a returning or past contracting skater. Skaters who are contracting for the first time will have the late fee waived.

### **Adding/Changing/Canceling Sessions**

Sessions can be added to a contract without incurring the late fee. Sessions changed or cancelled after the due date will be assessed a \$15.00 per session cancelled or changed. Injury credit will be given to those skaters who miss more than one week of skating and can show proof with a doctor's note.

### **Switching Sessions**

Skaters may switch contracted sessions only on the same day. For example: a skater is unable to skate their 7:45-8:45am time, and would like to skate 10:00-11:00am on the same day, they may do so. The sessions may not carry over to another day.

\*\*\*One exception will be among families with multiple skaters. Skaters in the same family may switch sessions amongst themselves, between any days, without penalty.

### **Summer Classes**

This summer the TRFSC will be offering a summer On Ice class. This class will be 30 minutes and be coached by TRFSC coaches on a rotating basis. Classes will only be held if at least 8 skaters are contracted for the classes. See the Attached Flyer for more information.

## ***Summer Vacation Policy***

### **VACATION Week #1**

**Coupons will be issued for 1 week  
(7 consecutive days) to use during the summer contract.  
Vacation credit requests MUST be turned in or  
emailed by July 1st, 2018. Coupons will be valid until 8/31/18.**

### **VACATION WEEK #2**

**A Second week of vacation coupons will be issued to use for the upcoming FALL 2017 session.  
Coupons will be issued for missed vacation hours (second week).  
Dates must be turned in no later than 8/4/2018.**
